<sup>1</sup> 220-RICR-30-00-4 was revised effective June 14, 2023, with a prequalification approval framework based on tiers instead of project dollar amount thresholds. Vendors who submit or have submitted prequalification applications under the new framework will be assigned a tier upon approval, while vendors whose applications were approved prior to the regulation revision date will be subject to the approved qualification amount until either their approval end date or upon submission and approval of an application to renew their prequalification.
